Welcome Back, Legislators

ore than 160 directors, managers and employees from Iowa's electric cooperatives discussed priorities with nearly 90 state legislators Jan. 11 during the annual Welcome Back Legislative Reception in downtown Des Moines. The Iowa Association of Electric Cooperatives hosted the annual reception in conjunction with the Iowa Biotechnology Association, the Iowa Communications Alliance, the Iowa Institute for Cooperatives and FUELIowa.

The event provided a valuable opportunity for Farmers Electric representatives to meet with state legislators at the beginning of the

2022 Legislative Session to discuss issues that impact our cooperative and the communities we serve.

"The opportunity to meet with our legislators in person gives our cooperative a voice in upcoming legislative issues that may affect our members," said Charlie Dunn, CEO. "Our board is very engaged with what's happening at the state level and will continue to monitor legislative actions throughout this year's session."

or years, Farmers Electric has rewarded its members for investing in energy efficient equipment. For those who are interested in taking advantage of money-saving rebates when considering energy efficient options should take note of changes to the co-op's 2022 rebate programs offerings, including the elimination of lighting incentives due to the increased availability and lower costs of these items. Rebates listed below became effective Jan. 1.

He's With Us! Meter Testing Underway

Every year, Farmers Electric inspects, tests and calibrates our electric meters for accuracy and mechanical condition, in accordance with the Iowa Administrative Code. This annual testing requirement ensures we address any adjustments, replacements or repairs needed to keep your electric bill accurate.

Our meter tech Scott Davis, will be visiting our members' locations and removing the

then returning the meter to service should it pass the test. In the event the meter does not pass the accuracy test, a new meter will be installed in its place. You do not need to be home for this process, and there is no need for Scott to enter your home.

Scott's service is something we share with neighboring Clarke Electric Cooperative. He will have identification on him and be driving the truck pictured (with the Clarke Electric identifier).

New Year Brings Out New Scam Attempts

ur cooperative was notified recently that one of our members received a phone call from a local number with the caller claiming to be an employee of Farmers Electric. The caller claimed our member was behind on their electric bill and that their power would be disconnected due to nonpayment.

Unfortunately, these types of calls are becoming more frequent. If you receive a similar phone call, please take these steps:

1. Verify. Farmers Electric will NEVER call and asks for payment. The best thing to do is hang up and call the cooperative to verify whether the call was legitimate.

2. Question the payment method. If the caller demands payment via a prepaid debit card or wire transfer, that's a red flag. These types of payments are hard to trace, and can be impossible for you to recoup your money once it is sent.

3. Don't be rushed. The caller may use a loud or demanding tone to intimidate and scare you. Remember that you are in control and simply hang up. There's no need for "Iowa Nice" when dealing with scammers!

If you are contacted by someone who you think is trying to scam you, please contact the cooperative to let us know and confirm it was a scam attempt.

No Robe Orea Chepspecke

16 oz. Cool Whip, divided36 Oreo cookies, divided (mini Oreos if desired for garnish)

1 can (14 oz.) sweetened condensed milk

3 pkg. (8 oz. each) cream cheese, softened

2 Oreo pie crusts (or make your own if you prefer)

In a large Ziploc bag, crush 24 Oreo cookies, keeping them

slightly chunky. Set aside. In a large mixing bowl, beat cream cheese with sweetened condensed milk for about 3 minutes until smooth and fluffy. Fold in 1 ½ c. (12 oz.) of Cool Whip and crushed Oreo cookies. Pour evenly into prepared OREO pie crusts. In the same Ziploc bag, crus remaining 12 Oreo cookies into fine crumbs. Sprinkle evenly over the tops of the two cheesecakes. Using the remaining 4 oz. of Cool Whip, pipe or use spoon to create small dollops around the edges to give it a finished look. Add mini Oreo cookies if desired. Refrigerate pie for 3 hours or overnight.



stick margarine
c. sugar
eggs
can Hershey syrup

Preheat oven to 350. Combine margarine, sugar and eggs and

beat with electric mixture until smooth. Alternate adding Hershey syrup and flour into mixture, beating after each addition. Spread batter in 11x15" baking dish. Bake at 350 for 30 minutes.

Frosting: Add margarine, sugar and milk to saucepan and heat over medium-high heat, stirring often, until boiling. Boil 30 seconds and remove from heat. Add chocolate chips and stir until smooth. Spread over cooled brownies.
